All other children are being taught by means of full-time remote education thus reducing numbers attending school and the potential for contact mixing. This is part of a national lockdown which came into force on 5 January 2021 and will be in place until at least February half term.</p> <p>Considering the above, the Covid control measures in place at the school have been reviewed and the school risk assessment updated and will be robustly followed and enforced. This includes those living in a household with someone who is clinically extremely vulnerable. <i>Pregnant staff are instructed to take particular care to practise frequent, thorough hand washing, and cleaning of frequently touched areas. As part of their risk assessment, it should be considered whether adapting duties and/or facilitating home working may be appropriate to mitigate risks.</i></p> <p>Staff who are 'clinically extremely vulnerable' are working at home when advised to do so by the Government/NHS during periods when national restrictions are in place [see note in Document History in relation to NCC employed staff] . Week 1 half the staff provide school based learning to children of Critical Workers and Vulnerable Children whilst the other half address home learning, planning and responding to home learning issues for those children not in school. Week 2 teams reverse. Staffing levels are reviewed 2 weekly. Kitchen, cleaning staff attend as normal to ensure enhanced levels of hygiene and hot meals for pupils.</p> <p><b>Children</b>  <a href="#"><u>Children in clinically vulnerable and clinically extremely vulnerable health categories (as defined by PHE guidance)</u></a></p> <p>Most children <u>originally</u> identified as ‘clinically extremely vulnerable’ (CEV) no longer need to follow shielding advice as more evidence has emerged that shows there is a very low risk of children becoming very unwell from COVID-19, even for children with existing health conditions. Those children whose doctors have confirmed they are still CEV are not attending school when advised to do so by the Government during periods of national or local restrictions. Appropriate arrangements should be made so that education can continue at home.</p> <p>Outside of these times, for those pupils in the CEV category, an individual risk assessment has been carried out in consultation with the child’s parents and the relevant healthcare professional(s). Advice from health professionals/GP involved in the child’s care is essential in these circumstances. The general arrangements below have been put in place to mitigate the risk where distancing cannot always be achieved.</p> <p><b>General arrangements</b></p> <ul style="list-style-type: none"> <li>• Pupils taught to adopt good hand and respiratory hygiene, to maintain suitable distancing (where possible) and to report if they are unwell.</li> <li>• Staff explicitly supervise health and hand hygiene arrangements for younger children and those with additional needs. Measures are in place to ensure more independent older pupils are following good hygiene practices.</li> <li>• Staff informally monitor for presence of symptoms.</li> <li>• Regular cleaning initiated (see below).</li> <li>• Where possible the same teaching staff work with the same groups</li> <li>• Where possible, the same groups are taught in the same classrooms or where this isn't possible, larger bubble groups are assigned 'zones' within the building.
